**ORDER**

Provisional affiliation was granted to EMEA Training College, Kondotty, Malappuram for starting B.Ed degree programme during the academic year 2005-06 with an intake of 100 students vide the U.O read 1st. Continuation of Provisional Affiliation to the programme for the academic year 2015-16 was granted vide the U.O read 2nd.

The Principal, vide the letter read 3rd, has requested to grant Continuation of Provisional Affiliation to the B.Ed programme in the college for the academic year 2016-17. The college has remitted Rs.1,30,000/ vide chalan No.152061267 dated 14/01/2016 towards administration and affiliation fee .

The National Council for Teacher Education, as per the order read as 4th, granted permission to the institution to have two basic units of 50 students each from the academic year 2015-16. Vide the U.O read 5th orders were issued to grant continuation of provisional affiliation to the Teacher Education Colleges, which were granted fresh recognition by the NCTE, following the introduction of Regulations 2014, and which were granted Continuation of Provisional Affiliation during 2015-16.

Considering the above, the Vice Chancellor has accorded sanction to grant Continuation of Provisional Affiliation to the B.Ed. programme in EMEA Training College (unaided), Kondotty, Malappuram(Dist) for the academic year 2016-17. The Continuation of Provisional Affiliation granted shall be subject to the condition that the management should abide by the provisions of the University Act, Statutes and Regulations of the University with regard to admission of students, collection of fee etc.

Sanction is, therefore, accorded for granting Continuation of Provisional Affiliation to the B.Ed programme in EMEA Training College (unaided), Kondotty, Malappuram(Dist) for the academic year 2016-17 as follows subject to the terms and conditions specified hereunder.

1. Selection and admission shall be made only on the basis of the Rules and Regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

2. In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998 the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

3. The conduct of University Examinations of any sort including that of S.D.E Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

4. Affiliation granted is strictly provisional and only for the academic year 2016-17. The college has to apply for the continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University, along with a copy of the letter of extension of approval from the National Council for Teacher Education.

5. Admission to the next academic year shall be made only after obtaining prior permission from the University.

6. A list of colleges which have renewed their provisional affiliation or applied for the continuation of provisional affiliation, will be forwarded to the Office of the Controller of Examinations to ensure that examinations are not conducted in those colleges which have not applied for the same.
